About Our Funds

Barbara L. Thomas Library Fund. The net income of this endowed fund provides financial support for the Columbus Public Library in Columbus, Kansas.

Charles & Jane Maxwell Scholarship, Charles L. McColm American Legion Memorial Scholarship, Class of 1986 Friendship Scholarship, Columbus Cares Scholarship, CUHS Alumni Association Scholarship, Dorothy Tyler Jackson Memorial Scholarship, Maureen Paulsen Memorial Scholarship, Nellie Hamilton Memorial Scholarship, and Sandra B. Houser Memorial Scholarship. Each of these funds provide financial assistance to graduates or graduating seniors of CUHS who are pursuing a higher education and meet additional eligibility requirements specific to each fund.

Columbus 4th of July Celebration Fund. This non-endowed fund supports the annual 4th of July celebration in Columbus, Kansas.

Columbus Benevolent Fund. This non-endowed fund supports select charities to help meet the emergency needs of local individuals.

Columbus Community Fields Turf Fund. This non-endowed fund supports the purchase of turf, ongoing maintenance and improvements, and other needs at Bomber Field and Rockette Field.

Columbus Operating Fund. This non-endowed fund supports the general operations of the Columbus Area Community Foundation.

Columbus Recreation Sports Complex Fund. This non-endowed fund supports the Columbus Recreation Commission with maintenance and improvements to facilities.

Columbus Sports Hall of Fame Fund. This non-endowed fund covers costs related to the induction of Columbus Sports Hall of Fame inductees.

Columbus Telephone Company Technology Utilization Fund. This non-endowed fund supports the implementation and use of technology by Columbus, Kansas, nonprofits.

Crossland Family Fund. The Crossland Family Fund supports improved recreational facilities in Columbus and provides scholarship opportunities for USD 493 graduating seniors.

Lee O. Pearl Memorial Fund. This non-endowed fund supports general charitable purposes at the discretion of the CACF board.

Miss Columbus Scholarship. This non-endowed fund provides scholarships for women who have been involved in the Miss Columbus pageant.
